EVALUATION OF QUOTATIONS

PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT NO. 5 OF 2000 AND ITS REGULATIONS WILL APPLY:

A Two (2) stage evaluation process will be employed. Stage One (1) Bids will be evaluated based on a set of Pre-requisites. Bidders must submit all the required documentation on Stage 1 in order to be evaluated on Stage 2. On Stage 2, bidders will be evaluated on Price (80) and B-BBEE (20) in accordance with the Preferential Procurement Regulations of 2017.

- The bidder must be SANAS Accredited to render verification services. Bidder must provide valid and certified proof of such accreditation reflecting the name of the bidding entity.
- The bidder must submit proof of business location within the Eastern Cape. Proof of address must be submitted in one of the following documents:
 - a) Lease Agreement;
 - b) Utility Bill;
 - c) Municipal Rates clearance; or
 - d) Municipal Account.

NB: Failure to provide proof of location in the above-mentioned format, will result in disqualification of the bidder

- The bidder must submit a minimum of three reference letters where they have rendered similar B-BBEE Audit Verification service to a similar sized entity. Proof of relevant projects completed must be submitted in one of the following forms:
 - Letters of Appointment,
 - o reference letter/s;
 - o copies of contracts;
 - Purchase Orders

NB: Failure to provide proof of relevant projects in the above-mentioned format, will result in disqualification of the bidder

- The bidder must submit CV, Proof of Qualification and Proof of Registration (Where applicable) of the Project Leader that will be assigned to the task.
 - CV, Qualifications and Proof of Registration (Where applicable) of the Project Manager/Project Leader with a minimum of 3 years relevant experience

Failure to submit both CV and Proof of Qualification and/or Proof of registration (Where applicable) will result in immediate disqualification of bid
