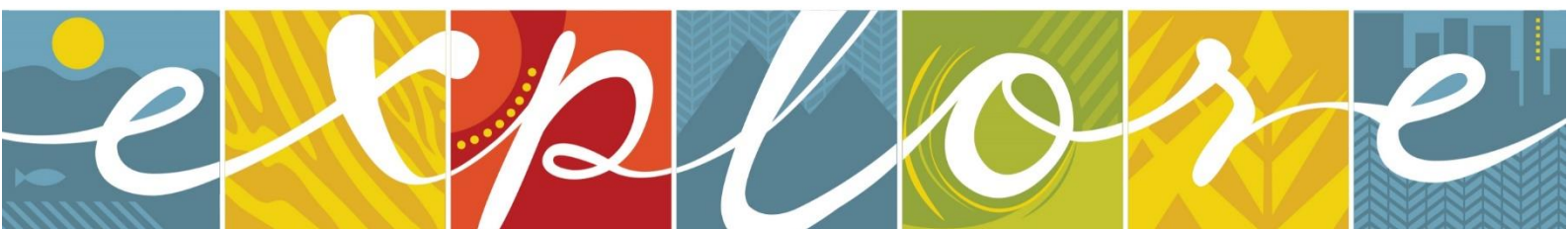


Terms and Conditions – Black Friday Promotion 2020

The following terms and conditions apply to the 50% Black Friday Promotion 2020:
