#### 1. PURPOSE

The purpose of these terms of reference is to secure a service provider with relevant expertise and experience to develop a business plan to refurbish and commercialize Bekile Building as a tourism hub.

#### 2. BACKGROUND

Bekile Building is one of the old beer halls in New Brighton located in ward 14 corner of Marwanqa and Mabija Streets, opposite Phakama Building. This building has been earmarked for tourism use as part of township tourism development to diversify tourism products offerings and experiences to increase the number of visitors to the township. This project is in support of the recently launched community tourism forum as a structure that facilitates community tourism development.

#### 3. SCOPE OF WORK

The appointed service provider will be expected to undertake the following activities to realize the objective of the project:

- 3.1. Assess the structural integrity of the building
- 3.2. Provide cost plan/ estimate for the following:
  - 3.2.1. Overall refurbishment of the structure including leaks, roof, flooring and relevant partitioning in line with the proposed layout.
  - 3.2.2. Plumbing work. Propose water saving and recycling mechanism.
  - 3.2.3. Electrical work. Propose alternative sources of energy and costing thereof.
  - 3.2.4. Engineering work if any as per structural engineer assessment report.
  - 3.2.5. Present basic sketches for the layout of the interior (is it basis / basic)?
- 3.3. Narrate how each facility/ space is going to be used and propose operational model. The following areas/purposes are envisaged in the building:
  - 3.3.1. Space for tourism SMME incubation
  - 3.3.2. Space for workshop
  - 3.3.3. Coffee shop with a Confectionery with sitting arrangement

- 3.3.4. Space to sell curios and memorabilia
- 3.3.5. Office space and boardroom
- 3.3.6. Design rooftop for events and entertainment
- 3.3.7. Any other tourism related use that may add value to the facility.

There are two community groups using part of the building for arts, crafts and training. The service provider should propose how these activities would be accommodated should the space prove to be feasible and relevant for the objective of the building.

The appointed service provider will be required to set up a well constituted project team responsible for development of a business plan to refurbish and commercialize Bekile Building as a tourism hub, the project team should at least comprise of the following disciplines, but not limited to:

- a) Engineering Profession (Electrical, Civil and Structural Engineer), registered with (ECSA), the Engineering Council of South Africa.
- b) Architectural Professionals registered with (SACAP) South African Council for the Architectural Profession
- c) Quantity Surveying Professionals registered with (ASAQS) Association of South African Quantity Surveyors;

#### **GENERAL CONDITIONS OF THE BID**

#### 1. Interpretation

The word "Bidder" in these conditions shall mean and include any firm or any company or body incorporated or unincorporated.

The word "ECPTA" in these conditions shall mean the Eastern Cape Parks & Tourism Agency.

#### 2. Extent of the bid

This contract is for the provision of the services as detailed in the attached Specification (page 7).

#### 3. Contract to be Binding

The formal acceptance of the Purchase Order by the ECPTA will constitute a contract binding on both parties. A service level Agreement will be signed by both parties

#### 4. Mode of the Bid

All Bids shall be completed and signed: All forms, annexure, addendums and specifications shall be signed and returned with the Bid document as a whole. *The lowest or any Bid will not necessarily be accepted.* The ECPTA wishes to deal on a prime contractual basis with the successful Bidder being responsible and accountable for all aspects of the entire solution or service offered.

#### 5. Quality

Should the specifications and / or descriptions not address any aspects of quality as specified, clarity should be provided to the ECPTA prior to the submission of a quotation.

#### 6. Insurance Claims, etc.

The ECPTA shall not be liable in any manner in respect of any claims, damages, accidents and injuries to persons, property or rights or any other courses of civil or criminal action that may arise from the carrying out of this contract.

When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the provider to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the provider in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

#### 26. Force Majeure


