### Terms of Reference to establish a Tourism Research Function for the Eastern Cape Parks and Tourism Agency

#### 1. Introduction

The Eastern Cape Parks and Tourism Agency (ECPTA) is mandated to serve as a catalyst for all dimensions of tourism in the Province. The roles and responsibilities of the ECPTA are described in the Eastern Cape Parks and Tourism Agency Act, 2010 (Act 2 of 2010), which states that the ECPTA has been established to develop and manage protected areas, as well as promote and facilitate the development of tourism in the Province.

Focus area	Objectives
Marketing (Domestic and International)	To increase destination brand awareness and positive association. To increase domestic and international tourist arrivals into the province. To penetrate other new markets. To profile the destination through an international and domestic stakeholder hosting programme and travel trade representative training programs.
Public Relations and Communication	To build and maintain a positive destination and corporate brand image. To drive internal and external communication through consistent messaging To promote a tourist-friendly environment.
Events Partnerships	To increase brand awareness and positive brand associations through event leveraging.
Research and Knowledge Management	To provide tourist information about the province To continuously measure the overall performance of the EC tourism sector To maintain an information and knowledge management system and databases including tourism service providers
Convention Bureau	To identify, evaluation and qualification of business tourism bid opportunities. To bid and offer bid support for identified bid opportunities. To source support from National Conventions Bureau (NCB) for the bidding process. To assist with delegate boosting and sourcing other forms of support for secured business tourism events. Promote EC as a business event tourism destination

The strategic focus areas for the Marketing Department are as follows:

The tourism information and research to be collated is essential for informing tourism destination development and marketing decisions. To meet its mandate, ECPTA requires an in-house capability to execute the following:

- Ability to survey tourists as they enter the province across all boarders into the province.
- Get monthly reports on international tourists visiting the province.
  - Get an insight into who the tourists are, what they are doing in the province, how long they are staying, activities that they plan on engaging and an indicative spend while in the province.
  - > Insight and baseline on the satisfaction levels of tourists visiting the province.

- Analyse, interpret and extract relevant tourism data from SAT's performance reports, Statistics SA, and other appropriate publications. This data must be consolidated into one report for presentation to Management.

#### 2. Scope of work

To ensure that ECPTA meets it mandate, the Entity seeks the services of a research company to set up an internal function for the capabilities mentioned above. The preferred service provider must deliver on the following:

#### 2.1 Main deliverables

- Set up a functional Tourism Information, Research and Knowledge Management function.
- Mining tourism data from different platforms (databases) and produce monthly reports for EC
- Establish contact and collaborations with hotel groups and other major accommodation establishments in the Eastern Cape to collate current and latest international tourists' numbers monthly.
- Establish, set, and test research methodologies and further produce reports that will form tourism research baselines for ECPTA and the Eastern Cape.
- Train and handover the set systems to ECPTA research team and ensure a smooth transition from service provider to internal management of the function.
- Setup a platform for data collection, dissemination, and broad analysis of research information.

#### 3. Timeline for delivering outputs.

The service provider must commence work by the 1 April 2021, a briefing session will be held on the day with the consultant at the ECPTA head-offices (17 – 25 Oxford Street, East London, 5201);

- A draft copy of the work must be presented to the Executive Chief Marketing Officer by the 25 February 2021.
- Testing of systems should be underway by 1 April 2021.
- Full on operation from 1 April 2021, with the first set of reports by end of April
- The service provider should hand-over the project to the ECPTA team.
- Annual 2020 performance in preparation for the annual report by July 2021

23.1 Subject to GCC Clause 25, if the provider fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed good or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

#### 24. Termination For Default

- 24.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the provider, may terminate this contract in whole or in part:
  - (a) if the provider fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
  - (b) if the provider fails to perform any other obligation(s) under the contract; or
  - (c) if the provider, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 24.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the provider shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the provider shall continue performance of the contract to the extent not terminated.

#### 25. Anti-Dumping and Countervailing Duties and Rights

25.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the provider to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the provider in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

#### 26. Force Majeure

- 26.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the provider shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that he delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 28.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 28.4 Notwithstanding any reference to mediation and / or court proceedings herein,
  - (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
  - (b) the purchaser shall pay the provider any monies due to the provider for goods delivered and / or services rendered according to the prescripts of the contract.

#### 29. Limitation of Liability

- 29.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
  - (a) the provider shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the provider to pay penalties and / or damages to the purchaser; and
  - (b) the aggregate liability of the provider to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding(or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
  - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
  - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- 4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bidrigging.
- 5 In order to give effect to the above, the attached Certificate of Bid Determination (SBD 9) must be completed and submitted with the bid:

Bid rigging is, therefore, an agreement between competitors not to compete.
