TERMS OF REFERENCE FOR THE APPOINTMENT OF A SANAS ACCREDITED B-BBEE STATUS VERIFICATION COMPANY TO VERIFY THE B-BBEE STATUS OF TOURISM ENTERPRISES IN THE EASTERN CAPE PROVINCE.

1. Objective

To comply with the Act, the ECPTA hereby invites experienced and reputable service providers to submit proposals to perform verification of tourism B-BBEE status and recognition level so that enterprises comply with the requirements of the Act.

2. Scope of Work

The scope of work for the services includes the following key activities:

- 1. Collect evidence and prepare the verification file;
- 2. Generate verification certificate confirming B-BBEE status and recognition level;
- 3. The agency must advice on critical success indicators mainly to improve the SMME's rating level;
- 4. The agency must present and issue final verification report to ECPTA's management team
- 5. The service provider will have to contact the tourism businesses and set appointments for engagements to facilitate the interventions. The service provider will provide his/her own transportation and meals to these tourism businesses.
- 6. In the event that the tourism business being verified has a turnover of less than R5m, the service provider will provide training support and ensure that the entity has a B-BBEE affidavit or certificate that is allowable as per the B-BBEE Act.

3. Duration

The appointed service provider will be so that expected to complete the work within one month from the date of appointment.

4. Requirements for proposals

On Stage 2, bidders will be evaluated on Price (80) and B-BBEE (20) in accordance with the Preferential Procurement Regulations of 2017.

GENERAL CONDITIONS OF THE BID

1. Interpretation

The word "Bidder" in these conditions shall mean and include any firm or any company or body incorporated or unincorporated.

The word "ECPTA" in these conditions shall mean the Eastern Cape Parks & Tourism Agency.

2. Extent of the bid

This contract is for the provision of the services as detailed in the attached Specification (page 7).

3. Contract to be Binding

The formal acceptance of the Purchase Order by the ECPTA will constitute a contract binding on both parties. A service level Agreement will be signed by both parties

4. Mode of the Bid

All Bids shall be completed and signed: All forms, annexure, addendums and specifications shall be signed and returned with the Bid document as a whole. *The lowest or any Bid will not necessarily be accepted.* The ECPTA wishes to deal on a prime contractual basis with the successful Bidder being responsible and accountable for all aspects of the entire solution or service offered.

5. Quality

Should the specifications and / or descriptions not address any aspects of quality as specified, clarity should be provided to the ECPTA prior to the submission of a quotation.

6. Insurance Claims, etc.

The ECPTA shall not be liable in any manner in respect of any claims, damages, accidents and injuries to persons, property or rights or any other courses of civil or criminal action that may arise from the carrying out of this contract.

The company shall insure his / her / their personnel and any plant, machinery or other mechanical or electronic equipment involved in the fulfillment of this contract and shall indemnify the ECPTA against all risks or claims which may arise. 7. Signing of Documents

8. Period of Validity for Bids and withdrawal of Bid after Closing Date

All bids must remain valid for a period of 90 (ninety) days from the closing date as stipulated in the Bid document.

8.1 Penalty Provision

Should the successful Bidder:

- a. Withdraw the Bid during the afore-mentioned period of validity; or
- b. Advise the ECPTA of his / her / their inability to fulfill the contract; or

9. Value Added Tax

In calculating the cost of the supply and delivery of services and / or material, the supplier will issue a "Tax Invoice" for all services rendered and / or materials supplied, which will reflect the exclusive cost of such services, goods or materials with the relevant Value Added Tax being added to the total. VAT must be included in the Bid price, but must be shown separately.

1. Definitions

- 15.5 If the provider, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the provider's risk and expense and without prejudice to any other rights which the purchaser may have against the provider under the contract.

16. Payment

- 16.1 The method and conditions of payment to be made to the provider under this contract shall be specified
- 16.2 The provider shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.
