OBJECTIVE

The Eastern Cape Parks & Tourism Agency (ECPTA) invites suitable service providers to render security and cleaning services for a period of one (1) year with an option to extend by one (1) year for Eastern Cape Parks and Tourism Agency's N2 Wild Coast Biodiversity Offset Project Office based at Lusikisiki. The appointed service provider shall provide quotations for the provision of cleaning service on the premises of the Eastern Cape Parks & Tourism Agency's N2 Wild Coast Biodiversity Offset Project Office. The Agency requires services of an external service provider for Cleaning Services to achieve ECPTA management objectives to ensure that hygiene requirements are met.

Scope of Works: Cleaning Services:

- a) Cleaning services shall be performed 5 days per week (Monday Friday), from 08:00 16:00 (8 Hours). This excludes public holidays. Cleaning personnel may however be requested to do deep cleaning over the weekend.
- b) ECPTA will require one (1) cleaning personnel per day to be stationed at the Project office. The allocated person will be responsible for the complete cleaning requirements of the building including assisting at the kitchen and boardroom when necessary.
- c) The allocated personnel are required to be properly trained and experienced to execute the job thoroughly.
- d) Cleaning personnel is required to wear uniform at all times while working on the ECPTA premises. She/he will also be responsible for wearing the necessary protective gear.
- e) The names of at least Three (3) cleaning personnel must be submitted with certified copies of their Identity Documents (I.D's).
- f) Leaving ECPTA premises unattended (during working hours) would be deemed as a breach of contract. If on three (3) occasions there is no cleaning staff on site, ECPTA will cancel the contract with immediate effect.

 - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the provider of any warranty obligations under this contract; and
 - (e) training of the purchaser's personnel, at the provider's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

25. Anti-Dumping and Countervailing Duties and Rights

26. Force Majeure


