TERMS AND CONDITIONS

1. Criteria for Eastern Cape Homestay Awards

The Eastern Cape Homestay Awards aim to ensure quality service and an authentic experience, and will consider the following two factors:

- 1.1. Eligibility criteria
- The property must have been in operation for at least 3 years.
- The homestay must be owned by South African citizens and be located within Eastern Cape.
- The property must be known or registered by the local municipality.
- 1.2. Evaluation criteria
- Quality of service provided to guests, including amenities, facilities, and overall guest satisfaction.
- Guest reviews and ratings of the homestay experience
- Uniqueness and authenticity of the homestay experience, such as showcasing local culture and traditions
- Adherence to safety, hygiene, and cleanliness standards
- Management and organization of the homestay, including leadership, and collaboration with the local community.

2. Categories

Below are the category-specific criteria

Homestay of the Year	The category recognizes a homestay that exemplifies excellence in providing a superior homestay experience	The property should have all elements as described in the evaluation criteria
Best authentic experience	This category recognizes homestays that offer authentic experiences, deeply rooted in local culture and traditions.	The property should have cultural or historical significance, and architectural features portraying local traditions
Hidden Gem	This category recognizes an exceptional homestay located in a less explored, tranquil rural area	The property must not be located in a township, town, or city
Best Service	This category acknowledges a homestay that handles processes	Management and organization of the homestay, timely
