Assignment Title: Consulting assignment for consultant services to conduct biodiversity assessment on candidate sites and develop management plan for a site within the Addo-Amathole Biodiversity Node.

The Government of South Africa, the Department of Forestry, Fisheries and the Environment has received financing from the World Bank toward the cost of the Catalysing Finance and Capacity for the Biodiversity Economy Around Protected Areas project and intends to apply part of the proceeds for this consulting services.

The ECPTA has identified candidate sites within the Addo-Amathole Node for potential declaration of community owned properties as protected areas. The biodiversity site assessment is required to determine the biodiversity value of each site to inform the protected area status should the site qualifies. Contract duration is eight (8) Months from December 2024 to August 2025. The location of the assignment is within the Addo-Amathole Biodiversity Node, in the Eastern Cape Province.

- That they have conducted Biodiversity Assessments for properties identified for protected • areas status in South Africa in the last 5 years.
- That they have developed protected areas management plans for declared protected areas or proposed protected areas.

Team Composition/ Capacity of the company to undertake the project. (An organogram will be sufficient for this stage) CVs of Key expert/s will not be evaluated at this stage.

1. Background

The Eastern Cape Parks and Tourism Agency (ECPTA) implements the Eastern Cape Biodiversity Stewardship Programme (BSP) which is guided by the Eastern Cape Protected Area Expansion Strategy (ECPAES), a systematic conservation planning product that identifies priority areas for conservation estate expansion and is aligned to the National Protected Area Expansion Strategy (NPAES). The ECPTA has identified candidate sites within the Addo-Amathole Node for potential the declaration of community owned properties as protected areas. The biodiversity site assessment is required to determine the biodiversity value of each site to inform the protected area status should the site qualifies.

2. Objectives

The objective of these terms of reference is to invite service providers to submit their interest to bid for providing services to the ECPTA, namely, conduct biodiversity assessment to the identified candidate sites and develop a protected areas management plan for one site.

3. Scope of Work

The service provider is required to determine the biodiversity value of each site listed on Table 1 below to inform the protected area status should the site qualifies. The appointed consultant will be required to perform the following deliverables.

- a. Conduct full biodiversity assessment for each site.
- b. Present biodiversity site assessment results in a report and at the Review Panel
 - Submit PowerPoint presentation in advance.
 - Present in-person the biodiversity site assessment results at ECPTA Review Panel
 - Submit assessment forms and related shapefiles.
 - Submit draft landowner notification letters •
- c. Property description.
 - Ensure that shape files for each site corresponds with the latest cadastral boundaries. •
 - Highlight any boundary issues that require attention i.e. discrepancy between cadastral boundaries and title deeds information.
- d. Submit Biodiversity Assessment Report.
- e. Develop/draft protected areas management plan (PAMP) for Brakfontein.

7. Contract Type and Duration

The ECPTA will enter to a formal Service Level Agreement, for an expected contract duration of eight (8) Months. The location of the assignment is within the Addo-Amathole Biodiversity Node, in the Eastern Cape Province.

FRAUD AND CORRUPTION

1. Purpose

1.1 The Bank's Anti-Corruption Guidelines and this annex apply with respect to procurement under Bank Investment Project Financing operations.

2. Requirements

- 2.1 The Bank requires that Borrowers (including beneficiaries of Bank financing); bidders (applicants/proposers), consultants, contractors and suppliers; any sub-contractors, sub-consultants, service providers or suppliers; any agents (whether declared or not); and any of their personnel, observe the highest standard of ethics during the procurement process, selection and contract execution of Bank-financed contracts, and refrain from Fraud and Corruption.
- 2.2 To this end, the Bank:
 - a. Defines, for the purposes of this provision, the terms set forth below as follows:
 - i. "corrupt practice" is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
 - ii. "fraudulent practice" is any act or omission, including misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
 - iii. "collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;
 - iv. "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
 - v. "obstructive practice" is:
 - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or



intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or

- (b) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under paragraph 2.2 e. below.
- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its subconsultants, sub-contractors, service providers, suppliers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring mis procurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in guestion, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti- Corruption Guidelines, and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such firm or individual ineligible (i) to be awarded or otherwise benefit from a Bank-financed contract, financially or in any other manner;² (ii) to be a nominated³ sub-contractor, consultant, manufacturer or supplier, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to

² For the avoidance of doubt, a sanctioned party's ineligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and bidding, either directly or as a nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

³ A nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider (different names are used depending on the particular bidding document) is one which has been: (i) included by the bidder in its prequalification application or bid because it brings specific and critical experience and know-how that allow the bidder to meet the qualification requirements for the particular bid; or (ii) appointed by the Borrower. participate further in the preparation or implementation of any Bank-financed project;

e. Requires that a clause be included in bidding/request for proposals documents and in contracts financed by a Bank loan, requiring (i) bidders (applicants/proposers), consultants, contractors, and suppliers, and their subcontractors, sub-consultants, service providers, suppliers, agents personnel, permit the Bank to inspect⁴ all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the Bank.

⁴ Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Bank or persons appointed by the Bank to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. Such activity includes but is not limited to: accessing and examining a firm's or individual's financial records and information, and making copies thereof as relevant; accessing and examining any other documents, data and information (whether in hard copy or electronic format) deemed relevant for the investigation/audit, and making copies thereof as relevant; interviewing staff and other relevant individuals; performing physical inspections and site visits; and obtaining third party verification of information.
