- Construction and/or repair of culvert structures.
- Cleaning out of existing hydraulic structures.
- Repairing of existing drainage inlet and outlet structures.
- Construction and/or repair of stone pitching at inlet and outlet structures.
- Installation and/or repair of gabion boxes and mattresses.
- Installation of road signs.
- Quality control and assurance.

The proposed works should take into consideration the space limitation in a protected area environment and where possible and use of existing infrastructure.
